Dr. Ross commented on Agenda Item 4.a.i. stating that although the topic is practical and interesting, it is not appropriate for continuing education. Additionally, he feels that there may be some sort of bias in this lecture since it was sponsored by a single consulting firm (Cochran Consulting). He noted that the lecture is seems to be an advertisement for their services. On this particular lecture he would vote not to approve. Dr. Garcia agreed.

Dr. Ross noted (as stated during the last PEC meeting) that Agenda Item 4.a.iv. (Having not received any additional information) is a high-quality lecture; nevertheless, it appears to have the issue of bias since the slide deck appears to have been compiled

by a single drug company. Dr. Garcia noted that although modification to remove bias would be nice for future applications, this lecture has already been presented. Dr. Ross explained that he would prefer to avoid issues of bias in future CE Course Approval Application reviews. He recommended that the Board's decisions regarding approval meet similar qualifications that entities like the Council on Optometric Practitioner Education (COPE) use to determine whether a course meets an objective threshold, and he will address this issue during Agenda Item 5. Future Agenda Items. Dr. Ross stated that since the lecture was already presented and is good quality CE material, he would vote to approve 4.a.iv.

- Discussion regarding the interface between BreEZe and ARBOs OE Tracker system – Updates and next steps.
- Review of the CE Course Approval Request application checklist, and possible addition of a stand-alone financial disclosure slide at the beginning of the presentation.
- Discussion on the current review process for continuing education course applications, qualification standards and a consistent review process.
- Possibility of adding a Diversity, Equity, Inclusion, and Belong (DEIB) requirement to the Board's continuing education.

Qualification Manual breaks down specifically on pages 7-12 what may be included in the agenda items for the next meeting. Two sections Dr. Ross finds particularly helpful are the COPE Standards for Integrity and Independence in Accredited Continuing Education on pages 7-10, and COPE Requirements for Course Qualification on pages 11-12. Dr. Ross noted that this information defines objectively criteria that needs to be met for continuing education to be considered high-quality. He believes this would certainly benefit the licensees taking the courses and will also be helpful to providers who are preparing their presentations.
