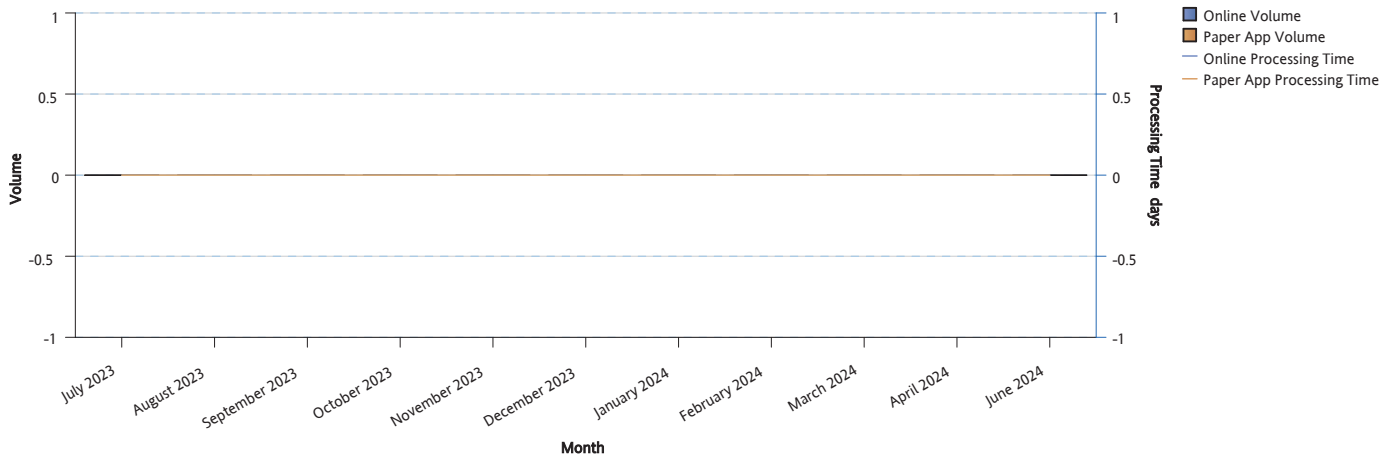
Registered Contact Lens Dispenser - Initial License

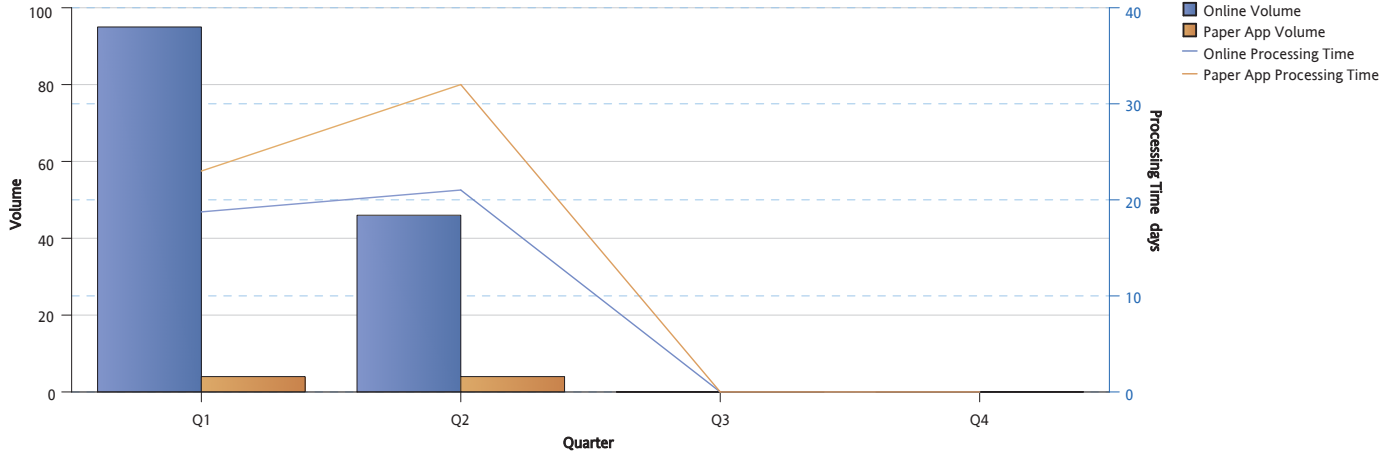
Registered Dispensing Optician - Initial Application



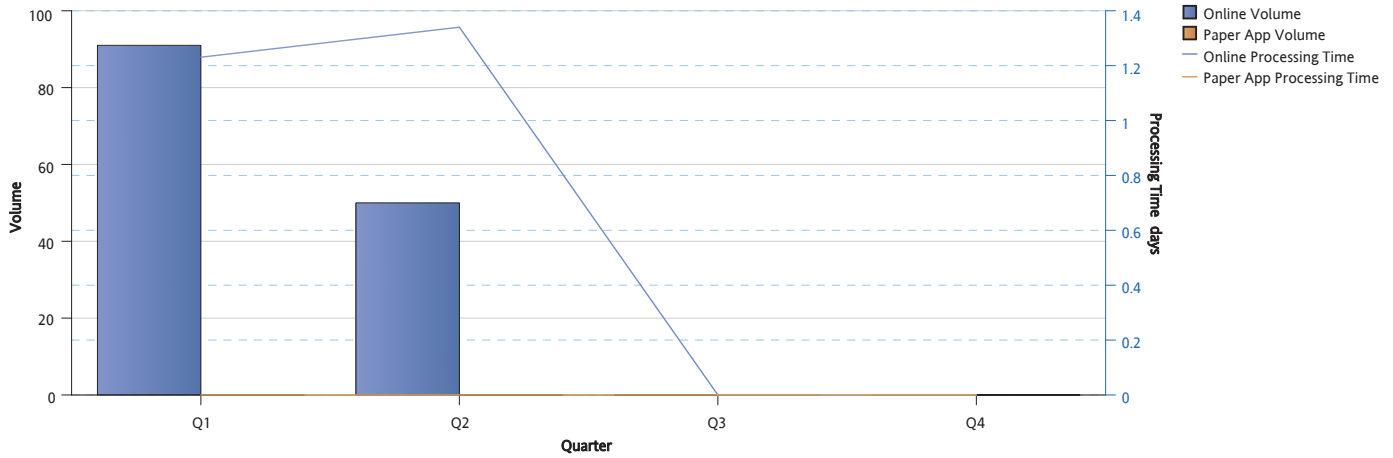

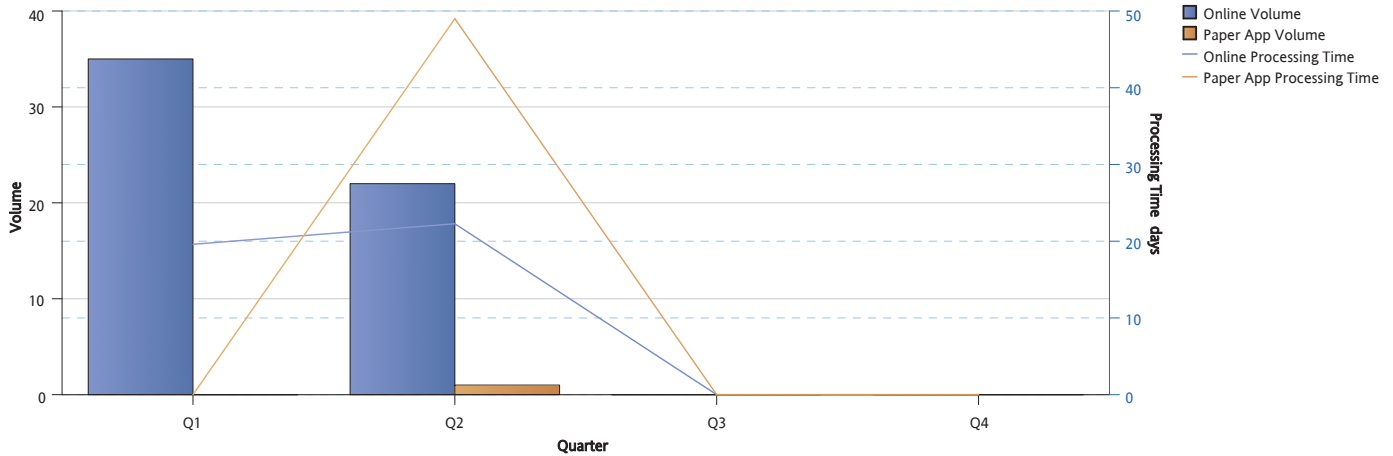
Registered Spectacle Lens Dispenser - Initial Application

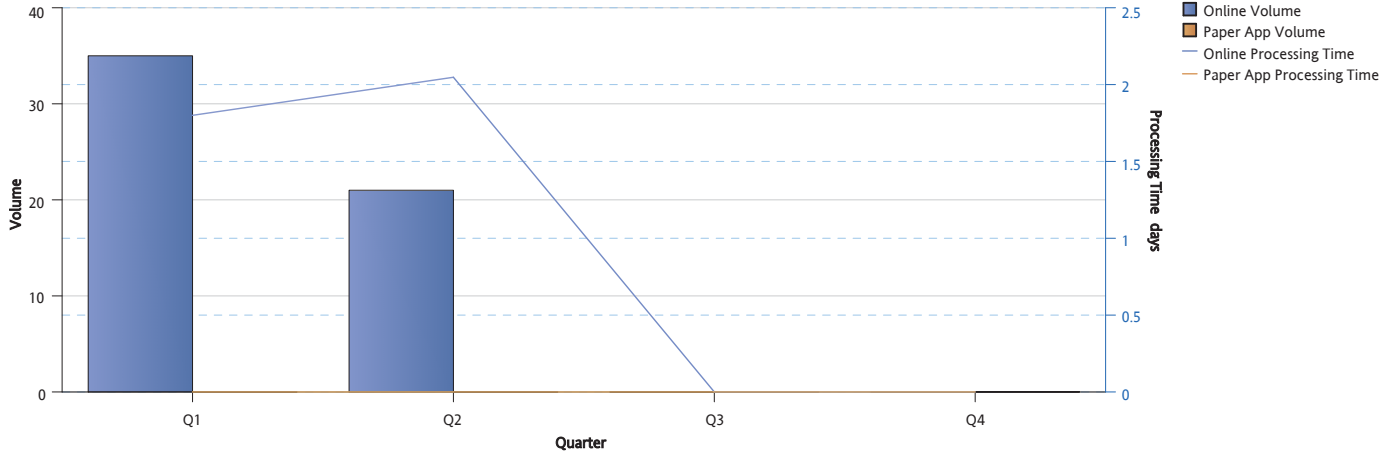




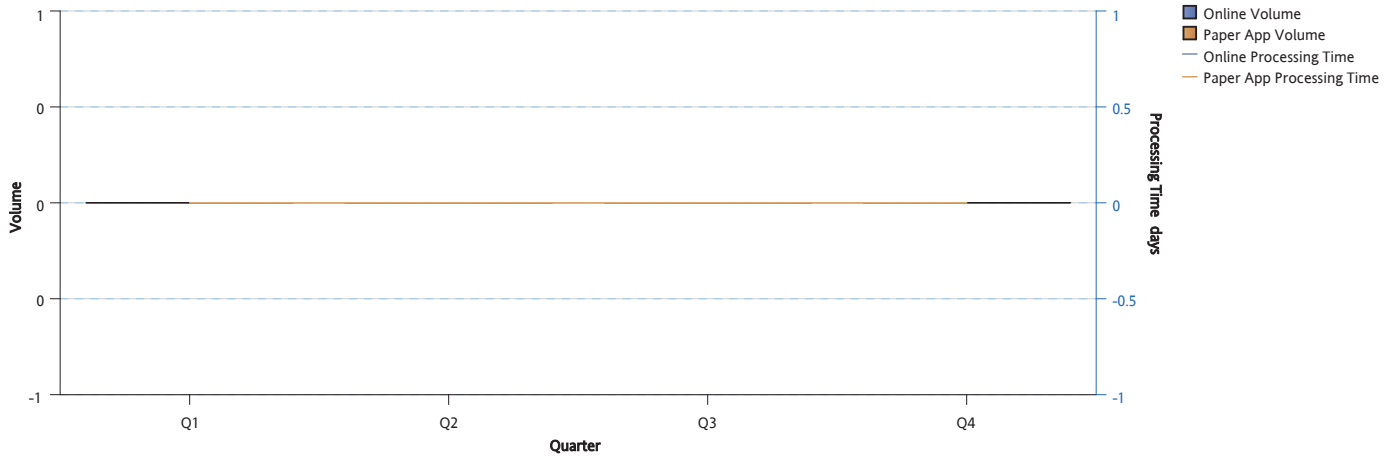
