SUBJECT	Agenda Item #7B– Executive Officer's Report - Enforcement Program

The Enforcement Unit has been focusing on reducing the number of aging cases. In June 2023 there were 44 cases aged over 1,000 days, as of today there are 2 cases older than 1,000 days. Of those 2, both are in the process of being resolved. Closures of the aged cases include bringing licensees/registrant's into compliance, receiving investigatory reports where further disciplinary action wasn't warranted, and pursuing administrative and disciplinary actions.

Enforcement staff will be cross-training within the unit throughout the next few months to ensure each analyst has experience in investigating all types of cases, knowledge of continuing education auditing, and processing correspondence from probationers.

Statistics:

- A. We are providing the priority/category of complaints, ranging from urgent to routine. That information is on attachment "7Bi" for Optometry and Opticianry.
- B. Probation monitoring statistics are available on the quarterly complaint statistics logs. There are currently a total of 8 licensees (OPT/OPN) on probation. Of these, 1 probationer is tolled and not receiving credit toward the completion of probation. 1 probationer was revoked during this quarter.
- C. Continuing Education Audits statistics are provided as attachment "7Bii". 34 audits have been completed in the quarter. Of the 34 completed, the statistics show 68 percent have passed (11 failed, 23 passed).
