**1. Call to Order/Roll Call**

**4. Presentation by Bonnie Delatorre on Marshall B. Ketchum University’s Glaucoma Rounds Certification Course; Possible Action**

*Audio of discussion: 05:52 / 01:46:57*

Bonnie Delatorre provided an introduction. The Southern California College of Optometry (SCCO) has many out-of-state optometrists who need this education. They have years of treating glaucoma in other states and are unable to provide this service to their patients in California. Although providers have been forced into providing CE in alternative ways due to the pandemic the educational value for this class may be increased. With virtual classes, the rotation is not necessary allowing for more interaction with patients. COVID GLC Rounds discussions include longitudinal management, side effects / contraindications; evidence-based medicine, and practical prescribing.

Dr. Salomora explained that they have been delivering Grand Rounds for quite some time and the goal is to deliver something equivalent while keeping in mind the safety of the doctors and patients. The idea is to use the Zoom platform with highly interactive discussions. Presentations will be composed of 50 live patients with doctors doing rotations of one hour per patient. Dr. Salomora noted that this method will be a huge time saver and be much more efficient. He added that poll questions will be included in the program to ensure active participation in the learning.

Dr. Chawla commented that in this type of situation, active engagement is important. Ms. Murphy asked for numbers regarding the number of students in the small group? Dr. Salomora replied that it would be 25 at the most. Dr. Wang asked how many faculty members will be involved; Dr. Salomora responded that they in this case of virtual presentations he does not think it would work well to have multiple faculty members present and it would not be practical. The Committee determined a future Grand Rounds course would be audited by the members. Dr. McIntyre questioned if the Committee audits the program around August 9-10<sup>th</sup> does that give the assumption that we have already approved the program, and we will be looking at something that is already in place; Ms. Murphy replied that it does make sense to see the demonstration via a Zoom call prior to August 9-10 and it would be a good primer to tentatively approving the course as is. The full Board would then approve the Committee’s recommendation.

Ms. Murphy suggested setting a time within the next two weeks so that the Committee Members may see the demonstration sometime during the week of July 6<sup>th</sup>. This would give the full month to sign up, prepare, and get the attendees ready for the August 9-10 offering if the demonstration is to the liking of the Members. Dr. Chawla agreed and added that she does not think the group needs to be any smaller

than 20 participants. Based on the information that Dr. Salomora has provided, Dr. Chawla anticipates that the Zoom call will go smoothly and be acceptable. The Board meeting is just a few days afterward and the recommendations can be brought to the full Board at that time and then move from there.

Public Comment: Dr. John Nishimoto, Senior Associate Dean of the Marshall B Ketchum University, SCCO. Dr. Nishimoto thanked the Committee for considering this alternative method of providing the glaucoma grand rounds certification course. He has been heavily involved with the glaucoma grand rounds courses and the virtual formats utilized during the COVID pandemic. Dr. Nishimoto believes that with the Board's input, SCCO can arrive at a very effective way at delivering an equivalent and probably an enhanced version of the program.

## **5. Discussion and Possible Action on Recommendation to the National Board of Examiners in Optometry for Additional Test Locations**

Drs. Jill Bryant, OD and Brooke Houck, PhD with the National Board of Examiners in Optometry (NBEO) provided a presentation for the Committee.

Dr. Bryant provided the NBEO's Mission Statement and Statement of Purpose and explained that to achieve their purpose they spend a significant amount of time talking about the Minimally Qualified Candidate (MQC). NBEO exams must be sufficiently demanding and rigorous to meet the "good faith" expectations of public protection. She assured that every staff member takes these expectations very seriously. The Part III clinical skills exam is given in Charlotte, North Carolina. Dr. Bryant stated that the NBEO analysis report was updated in 2018 after listening to concerns from students for an expressed desire for a second testing location on the west coast. Multiple factors were considered, and it was determined that one quarter of optometry students are on the west coast. Standardization is a major component for the Part III exam and having the single testing center has had a positive impact on standardization.

Dr. Bryant discussed the impact COVID-19 has had on the NBEO. As of March of 2020, the NBEO temporarily suspended testing beginning March 17 and the Part I exam was cancelled because Pearson VUE testing centers closed across the country. The April Part II PAM/TMOD was also canceled subsequently. The testing cycle for the graduating class of 2021 is scheduled to begin August 1st and runs through July 31<sup>st</sup> of next year. She noted one of the NBEO's largest concerns is ensuring that there are enough standardized patients to keep the testing operational. Staff has been recruiting more standardized patients and increasing NBEO's numbers which has been successful. Dr. Bryant summarized NBEO's communications plans both external and internal and NBEO's continual steps. She expressed appreciation for the Committee's support.

Dr. Houck provided her presentation on alternative testing consideration in response to COVID-19. They have looked at remote proctoring, paper and pencil testing, and

utilization of the schools and colleges of optometry to administer the examination in a computer-based format. Regarding remote proctoring, Dr. Houck assured they are watching this technology closely as it develops further. However, currently the technology does not offer enough testing security. In terms of pencil and paper testing, the protocols for maintaining test integrity take time to establish. The third option is to continue to offer computer-based testing but to offer it at the schools and colleges of optometry. She noted that the largest obstacle discovered in research literature around this idea is that there are different experiences at different schools and that there is an extensive time delay to switching test files from Pearson VUE format to another format. Dr. Houck assured that the Board of Directors conducted a rigorous study to identify the best location for a national testing center.

Dr. Wang asked if the NBEO is not considering any type of remote testing location at all for those graduates who do not wish to travel across the country during COVID? Dr. Bryant replied that the NBEO is concerned about the safety of all candidates and staff. This is the reason why the NBEO has put into place comprehensive safety measures. Dr. Bryant assured that they understand that some candidates who may not wish to travel to Charlotte at this time. The NBEO has relaxed its rescheduling rules. Candidates may reschedule at absolutely no penalty to them, and they may reschedule at any point during the testing cycle over the course of a year. Dr. Bryant explained that asking the NBEO to come to a different location would mean having to bring staff, standardized patients, and examiners to a site that has a very specific time and location. Also, all the differences in governmental regulations could make this quite challenging.

Dr. Chawla commented that Dr. Houck's presentation was very helpful. She understands that this is not an issue because the NBEO does not sympathize with the candidates; it is a problem because they simply do not have the time to implement such a change.

Public comment was taken from Dr. Tracy Montez. Dr. Montez expressed appreciation for the presentation from the NBEO. She assured that the OPES is supportive of standardization for consumer protection. She requested that the NBEO continue researching the idea of a second location in the long term.

Ms. Murphy suggested, and Dr. Wang agreed to direct staff to continue communications with the NBEO and to possibly discuss, at the Board's October 23, 2020 meeting, long-term solutions for this issue.

**4. Discussion and Possible Action on Title 16, California Code of Regulations Section 1571 (Glaucoma Grand Rounds Program); Recommendation to Full Board**

Dr. McIntyre confirmed that she and Dr. Wang did not have any issues with the glaucoma presentation other than that a couple of the patients were not dilated. Dr. Wang stated that she had a conversation with one of the head doctors in charge of the on-site program; she explained that there were one or two patients who could not be dilated due to medical conditions.

Dr. Wang announced that Marshall B Ketchum University (MBKU) had to obtain a waiver for their virtual grand rounds course. MBKU suggested that this Committee make a recommendation to the Board to strike the phrase “patients must be evaluated in person”. Dr. Wang explained that the glaucoma grand rounds programs are very expensive to run, so the universities are offering fewer of them than in previous years. Therefore, breaking the barrier of evaluating patients in person will make the course more accessible to students and optometrists. Dr. Chawla noted that the majority are glaucoma certified upon graduation, so the number of persons needing these courses will become fewer and fewer. Drs. Garcia and Chawla stated that they would be okay with changing the language to be somewhat more liberal to presenting online.

Dr. Garcia asked if this change would, in any way, go against the original scope expansion with glaucoma language? Ms. Murphy responded that within this statute there is no change. This would just be within the Board’s regulations. The language “patients must be evaluated in person” is the only barrier; there will not be any change in the scope as far as the statute is concerned. Drs. Garcia and McIntyre expressed their support of the recommendation.
